BOARD NEWS

The Board is seeking volunteers interested in creating a Twin Rivers Information Committee made up of Twin Rivers homeowners to share information between the two Associations so we can then share on ML Website.

While the Board was previously advised by the HOA Management Company that Twin Rivers homeowners could not volunteer on Meadowville Landing Committees, due to TR subsection being a separate association, they have since sought additional clarification and TR homeowners can now volunteer. YAY! Represent!

Solar collectors/panels can now be installed on the front or side roof of the house but MUST accompany a report from an independent solar panel design specialist, certified by the North American Board of Certified Energy Practitioners who is

licensed in Virginia.

The Board has requested that Becca with ACS West acquire proposals from structural engineer and construction companies

for ways to remedy the clubhouse water intrusion.

Dock security was a major sticking point for homeowners at the last meeting. The Board has contacted Chesterfield County to see if the community can add concrete barriers, bollards, or a gate for the dock located in Mount Blanco. Per Chesterfield County Plans Office, we cannot place bollards or a gate because it is a public road and VDOT will not allow it. We could acquire a special license but then the community would be liable for the maintenance and road repairs. To cover these costs, HOA dues would need to increase. Majority of the homeowners at the meeting were not interested.

The addition of light poles in the parking lot near the playground area is underway. Becca received a verbal quote of \$5-10k

and the additional lighting should deter further suspicious activity.

The HOA Management Company only received one proposal for a preventative maintenance contract- the vendor would be responsible for identifying any potential repairs/preventative maintenance issues on a quarterly basis to the Board and conduct repairs as needed.

ACS West only received one proposal for Website maintenance for the Meadowville Landing website. The Board will reach

- out to the vendor to fine tune a few bullet points and if agreement is made, will be hired on a one-year basis. The Board received feedback from approximately 13% of the community regarding additional playground equipment for ages 2-10 years old. The majority of the feedback is to just beef up what is there. The Board has asked Becca to acquire updated quotes to potentially have this completed for the summer season.
- Feedback in the survey for adding a basketball and tennis court was received. While we would like to add these, the community would need to identify an area that would accommodate this without disturbance, come up with \$100,000 to purchase/install and maintain, and cover the additional insurance costs. The Board made note that we need to focus on paying off the clubhouse/Pool before adding to community debt. Those who attended the meeting agreed. This can be explored in the future.
- We should receive a Reserve Study within 30 days. This is a requirement to the Clubhouse/Pool ortgage. The remaining balance is approximately \$500k. We cannot refinance because the community is still being developed.
- A quote was received for the dock repairs at Mount Blanco totaling \$34k. The Board is getting clarification on the scope to make an informed decision.
- We are seeking more volunteers for our community committees. Our current committees are:
 - Fitness Center/Clubhouse Committee: Looking to change out old equipment and possibly add new items.
 - Pool Committee: excited to announce we have received a partial shipment of furniture and umbrellas. The remaining order should be here before the pool season begins. Pool repairs (pump, pool lining, concrete cracks, etc.) are scheduled for spring and all repairs are expected to be completed before pool season opens.
 - **Grounds Committee**: Currently not in operation. IN NEED OF VOLUNTEERS.
 - Welcome Committee: Finally starting back up! Come to the meet and greet Feb 25 from 2-5pm at the Clubhouse.
 - Social Committee: The SpringFest tentative date is April 15th. More information to follow and will be requesting donations in the coming months.
 - Neighborhood Watch: Neighborhood Watch committee works closely with the Chesterfield County Police Department and is the source of necessary information and training in keeping our community safe. They sponsor cleanups, encourage residents to beautify their area, and ask to turn on outdoor lights at night. Physical conditions (abandoned cars, overgrown lots, etc.) contribute to crime. This group is not vigilantes and are not assuming the role of the police. They ask neighbors to be alert, observant and caring. Report suspicious activity and crimes to the police. The nonemergency number is 804-748-1251.
 - Architectural Review Sub-Committee: Responsible for reviewing all proposed homeowner projects for compliance with the HOA ARC Guidelines. A time intensive committee and members are required to log in and vote weekly. There are also times when committee members reach out to neighbors for additional info. Application online at https://office.smartwebs.com/Arc/SWForms/index.cshtml#/forms/7f26453a-7607-ed11-8122-8a7624ba6641. If guidelines are followed and all information filled out, applications can be processed quickly. Use email you check often.
 - Communication/Newsletter Committee: The newsletter is written quarterly and shares information from the Board of Directors, Committee information/events, advertise businesses, and celebrate with our neighbors. Will begin utilizing the push notification system (text/email) and urge homeowners to sign up and update your profile at meadowvillelanding.com.


